Basic Offshore Safety Induction & Emergency Training (with Emergency Breathing System) and Travel Safely by Boat (OPITO Approved)

WHO IS THE TRAINING FOR?

This training programme is designed to meet the initial offshore safety and emergency response training requirements for personnel new (or returning) to the offshore oil and gas industry who will be supplied with a rebreather emergency breathing system (EBS) during offshore helicopter travel and/or transferring by boat to an offshore oil and gas installation

WHAT DOES THIS TRAINING COVER?

The aim of the BOSIET (with EBS) and TSbB is to introduce delegates to the specific safety issues and regimes relevant to offshore installations, and to equip them with the basic emergency response knowledge and skills for travelling/transferring to and from offshore installations by helicopter and/or by boat.

The objectives of the BOSIET (with EBS) and TSbB are that delegates will be able to:

- Identify the generic hazards which are specific to offshore oil and gas installations, potential risks associated with those hazards, and how controls are put in place to eliminate or reduce risks.
- Identify key offshore related safety regulations and explain the basic safety management concepts
- Demonstrate, in a simulated environment, that they can use the safety equipment, and follow procedures in preparing for, and during helicopter emergencies - with particular focus on escaping from a helicopter following ditching
- Demonstrate sea survival and first aid techniques
- Demonstrate that they can effectively use basic firefighting equipment, and practise self-rescue techniques in low visibility situations, to include smoke filled areas.
- Demonstrate donning of an appropriate floatation device as used during boat transfers e.g. work-vest
- Demonstrate a method of transfer between a simulated boat deck and a simulated fixed installation deck using swing rope transfers with luggage transfers
